REPORT OF THE PRESIDENT, UERMMMC-MAAA, INC.

To: Chairman Benjamin Rigor, M.D., Board of Trustees and Friends UERMMMC Alumni Foundation USA, Inc.

We respectfully report the ff:

- 1.) UERMMMC-MAAA, Inc. continues to be a solid non-profit organization and is now approved by the Internal Revenue Service to be a 501 (c) 3 tax-exempt corporation with all its privileges.
- 2.) The Northeast Chapter is working hard to bring to all alumni and friends exciting activities at the 21st Annual Convention & Reunion to be held at Waldorf=Astoria Hotel, New York, New York on July 2-5, 2009.
- 3.) At the 2008 General Membership Meeting in San Francisco it was approved that the Drug Assistance Program (DAP)/ Indigent Fund should also provide funding for community projects. For clarification to the new set of Board of Trustees, the main and major donor of the DAP/ Indigent Fund is UERMMMC-MAAA, Inc.
- 4.) The Executive Committee of UERMMMC-MAAA, Inc. recommends the ff:
 - (a) For Fiscal Year 2008-2009, disbursement should be as follows:
 - (i) \$50,000 ó for the 4 medical clinics at the Antipolo Green Building Project building that will be used on indigent patients of the community that will be served by medical students studying at UERMMMC College of Medicine.
 - (ii) \$25,000 ó for the Indigent Patient Fund of UERMMMC Charity Hospital.

(b) Fiscal Year 2009-2010, disbursement should be as follows:

- (i) \$25,000 ó for the purchase of necessary medical instruments and maintenance of the 4 medical clinics mentioned above.
- (ii) \$25,000 ó for the Indigent Patient Fund of UERMMMC Charity Hospital.

- 5) The Executive Committee of UERMMMC-MAAA, Inc. recommends that the checks for \$50,000 grant money for the Antipolo Green Building Project and the \$25,000 grant money towards the Indigent Patient Fund of UERMMMC Charity Hospital be handed to the designated representative/s of the grantees during the General Meeting of the Membership of UERMMMC-MAAA, Inc. on Friday, July 3, 2009.
- 6) Copies of this report will be given to all Alumni attending the 21st Annual Convention and Reunion and will also be published at the Association website: www.uermalumni.org and Alumni Newsletter.

We thank the Chairman and the Board of Trustees for facilitating disbursement of the much needed funds that will help not only our medical students in their training to become better physicians, but will also help the poor citizens being supported by UERMMMC.
